At the start of the first business session, the Chair will present the report of the Procedures Committee and its recommendations. The Chair will introduce most of the items in the report. Subsequently, The Secretary will explain how the Governors' statements will be delivered. The Chair will then call one Governor at a time to deliver his or her statement and thank each Governor at the conclusion of his or her address. There are usually no unannounced interventions or discussions, but a scenario will be provided in the script should Governors wish to comment on an agenda item. Most of the items on the agenda will be taken up during the first business session.

#### **Second Business Session**

The Chair will call the meeting to order and continue to call on the Governors to deliver their statements. After the last statement is delivered, the Governors will consider the rest of the items on the agenda. The Chair-elect (usually the Governor of the next host country) will give a brief statement, followed by the closing remarks of the ADB President and the Chair. Just before the conclusion of the second business session, the ADB President will present gifts of appreciation to the Chair and Vice-Chairs, and the Chair will present a token of appreciation to the Chair-Elect. Afterwards, the Chair will close the meeting.

## D. Business Session Matters Requiring Special Attention

1. **Use of the name of Taipei, China.** If the Governor for Taipei, China or any Governor refers to Taipei, China by any other name, the Chair or Vice-Chair at the time needs to remind the participants by stating:

"Fellow Governors, I would like to clarify for the record that ADB recognizes the member only by the name Taipei, China."
